The contract shall then be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification.

A set of bidding documents will be obtained from the office of the BAC Secretariat upon payment of a non-refundable fee of **Five Hundred Pesos (Php 500.00)**. Interested bidders may drop their proposals with the price quotation on the above-mentioned project accompanied by bid security (specified in RA 9184) on **September 29, 10:00 o'clock in the morning** at the **Second Floor of Municipal Building (main) of Sison, Surigao del Norte** in the presence of participating bidders or representatives who choose to attend.

The Head of the Procuring Entity of Sison reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
